#### SUPPLY FORM

Styrenix PS 434 is supplied as cylindrical shaped granules. It has to be kept in its original containers in a dry, cool place. Avoid direct exposure to sunlight. Styrenix PS 434 can also be stored in silos.

### **PROCESSING**

Styrenix PS 434 can be processed by any method applicable to polystyrene based plastics, it is best suitable for injection molding and extrusion molding. Recommended processing at temperatures between 180 and 280°C and mold temperatures are between 10 and 60°C. The melt temperature should not exceed 240 °C.

### PRODUCT SAFETY

During processing of Styrenix PS resins small quantities of styrene monomer may be released into the atmosphere. At styrene vapor concentrations below 20 ppm no negative effects on health are expected. In our experience, the concentration of styrene does not exceed 1 ppm in well ventilated workplaces - that is where five to eight air changes per hour are made.
